

# 1) Liability Waiver Declaration concerning the event “Agnellotreffen 2027 – 13th Edition”

# 2) Information Notice for Participants in Agnellotreffen 2027 – Regulation EU 2016/679 (GDPR)

Moto Raid Experience S.r.l. informs that, for the establishment and management of the relationship with you, it processes your data considered as personal data under EU Regulation 2016/679 on the protection of individuals with regard to personal data, effective from May 25, 2018.

According to Article 13 of the Regulation (data collected from the data subject), we inform you of the following:

The Data Controller is Moto Raid Experience S.r.l., headquartered in Saluzzo (CN), Corso Piemonte 30, Italy.

The Data Controller has not appointed a Data Protection Officer (DPO).

The purposes of processing your personal data include communication regarding Agnellotreffen and other trips, events, or similar initiatives organized by Moto Raid Experience S.r.l., including the publication of photos and videos (with your image or that of your motorcycle) via the communication tools used by Moto Raid Experience S.r.l. and its affiliated companies (sponsors and partners of the event).

The following categories may have access to your data: employees, collaborators, external companies, and associations cooperating with Moto Raid Experience S.r.l.

The transfer of personal data to non-EU countries shall only take place with the explicit consent of the data subject. As for the data retention period, the data subject has the following rights regarding their personal data:

To request access, rectification, deletion, restriction of processing, and data portability;

To object to processing and revoke their consent;

Providing data is necessary for the provision of services: refusal to provide data (in whole or in part) may result in the impossibility of delivering the requested services (in this case, participation in Agnellotreffen) and fulfilling the related obligations.

There are no automated decision-making processes related to the provided data.

The Data Controller does not intend to process data for purposes other than those for which it was collected.
